Successful completion of the examination earns the candidate IFSAC certification in Fire Fighter I, Hazardous Materials Awareness, and Hazardous Materials Operations

The examination is composed of written tests including Fire Fighter 1, (100 questions); Hazardous Materials Awareness (25 questions); Hazardous Materials Operations (50 questions), and practical skills demonstrations.

Those wishing to take the examination can request skills sheets to study.

Pre-registration is required.

Applications will be accepted on a 'first-come, first-served' basis and must be received by 5pm on September 27, 2019. Applications are available at www.wvpst.org – go to the calendar on the date of the testing.

Testing will be cancelled if minimum number of applicants is not met.

The fee for taking the examination is \$25 per certification (total of \$75 which is non-refundable).
