COURSE DESCRIPTIONS

WVOEMS Agency Training Officer

This course is required within legislative rule 64.48 for all Agency Training Officers and Educational Institute Training Coordinators. It provides the tools Agency Training Officers need to successfully manage provider education compliance in West Virginia. Learn your role, understand state requirements, and gain hands-on experience with the ImageTrend LMS to track credentials and continuing education. Educational Institute Coordinators, which support their Program Directors, will also gain the knowledge needed to support instructors in adhering to WVOEMS educational policies and procedures, ensuring consistent, high-quality instruction across all training programs.

Prehospital Blood Administration Train-the-Trainer

This course is designed for training providers approved by WVOEMS to instruct the Prehospital Blood Administration Initial and Annual Courses. Providers MUST meet WVOEMS requirements and be approved to take this course. In order to complete WVOEMS screening requirements, registration must be completed by November 21, 2025, to attend.

WVOEMS Requirements for Blood Administration Instructor: Attended and passed Prehospital Blood Administration for Ground EMS Initial Course; Current WVOEMS Instructor; Hold C3IFT endorsement or higher; and Performed at least 5 out of hospital blood transfusions

Physician criteria for becoming an instructor: EMS experience Performed at least 5 out of hospital blood transfusions *This course is provided free of charge*

Traffic Incident Management (TIM) Train-the-Trainer

The National TIM Responder Training Program was developed by responders for responders, and was designed to promote consistent training of all responders to achieve the three objectives of the TIM National Unified Goal (NUG):

- Responder Safety
- Safe, Quick Clearance
- Prompt, Reliable, Interoperable Communications

The Train-the-Trainer (TtT) course is intended to provide participants (i.e., trainers) the knowledge and materials necessary for them to conduct TIM training for responders in their area or state. The TtT includes classroom training and hands-on activities.

Participants must be TIM credentialed prior to taking this course.

The Ultimate House Fire

This program focuses on highlighting the behavioral health concerns of first responders and family struggles. It covers the issues first responders face, statistical data, and many personal testimonies are shared. It is a program designed to awaken the heart and save firefighters lives, marriages, and their families. The course contains three parts as listed below:

Introduction-The Call Comes In!

Part 1 - Defining the Problem-Real statistics on Real Life Problems

-Anxiety & Depression - Stress - PTSD - Alcohol Abuse - Substance Abuse

Part 2 - Defining the Problem-Continued

Financial Problems - Firefighter Suicide - Marriage, Conflict, & Divorce

Part 3 - Saving Our Families (The Greatest Rescue)

Solutions to Problems - The Great Hypocrisy/Great Redemption - Fighting the Fires of Our Lives - Balance & Overcommitment - The Courage to Commit: We close with a challenge.

This class is done to serve first responders, and any proceeds raised from "The Ultimate House Fire Program" are donated to firefighter/first responder-based charities.

Tactical Thermal Imaging

Today's firefighters are facing unique challenges compared to their predecessors. Live fire training is restricted in regard to fuel loads, and it is often difficult to acquire on a regular basis unless they are fortunate to have a Class A training facility. And even with a Class A Burn building, firefighters are being shown fire behavior definitions and concepts in a nonrealistic environment due to the limitations on the types of fuel loads that can be used and ventilation conditions. However, with the Max Fire Box, students can witness firsthand fire behavior definitions like never before! These definitions literally "come to life" before their eyes and they are able to comprehend them in a safe environment prior to witnessing it inside a live fire environment. This training equates to better prepared, more educated, and safer firefighters; or what we refer to as "intelligently aggressive" firefighters. This classroom hybrid training consists of a 2.5-hour classroom session followed by a 1.5 hour live fire demonstration with the Max Fire Box where those concepts are brought to life before the firefighter's eyes. This class is engaging, provides hands on time with thermal imaging cameras, and the class provides additional resources for the students in the form of a student manual in PDF format along with access to a shared drive folder with a large amount of thermal imaging resources.

The morning session will discuss various teaching techniques and philosophies, active and dynamic learning methods, and preparing students for the street as well as the NREMT examination.

We Can't Continue to Ignore What's Killing Firefighters

What was once a topic nobody talked about has now risen to the top of the list of causes of firefighter line of duty deaths. Occupational cancer in the fire service can no longer be ignored. This class will look at all facets of cancer in the fire service beginning with prevention, education, early detection/screening programs, diagnosis, treatment, coping, and life after diagnosis and treatment. The course instructor will speak from a position of unfortunate real-life experiences, in the hopes of spurring changes across the industry.

No Excuses: Tactics for the Understaffed Fire Department

Many fire departments are understaffed, but that is no excuse not to be prepared. In this class the presenter will discuss building a tactical playbook for your response. Just as a quarterback will read a defense to ensure the play called meets the situation, your playbook sets expectations but allows responders to pick the best tactic or "play" for the current conditions. Attendees will gain a greater understanding of how to develop tactical options that fit in the context of the understaffed department.

Topics Covered:

- Defining "Understaffed". Who gets to pick the number?
- Overcoming the defeated mindset, moving away from "woe is me."
- Laying the foundation through a thought-out training process.
- Creating better decision makers on all levels of the organization.
- The Playbook Mentality: Calling the fireground tactic that works for you.
- Equipping your firefighters for success.

<u>Teaching and Testing for Success - Part II</u>

The second half of the presentation continues the conversation on success in the classroom and transitions into item writing. Creating effective classroom evaluations not only provides fairness and objectivity in grading but also sets a standard students must meet. It is said that testing superficially causes students to only learn superficially. Testing comprehensively requires students to learn comprehensively—like we want them to learn. Find out how to make your examinations work for you!

Educating for Impact: Understanding PTSD in Emergency Services

As educators and trainers working with EMS and fire service personnel, it's vital that we understand the unique psychological toll these professions can take. In this course, we will examine Post-Traumatic Stress Disorder (PTSD) through the lens of emergency response—exploring how repeated exposure to trauma, critical incidents, and high-stakes environments affects mental health. My aim in teaching this course is to help fellow educators recognize the signs of PTSD in their students or trainees, foster trauma-informed teaching practices, and integrate mental health awareness into curriculum and field training. We will cover foundational knowledge of PTSD—its causes, symptoms, and treatment—while also focusing on the culture of silence and stigma that often prevents first responders from seeking help.

Topics include:

- The psychological impact of critical incidents
- PTSD vs. acute stress response
- Behavioral signs in the classroom or training environment
- Culturally competent support for EMS/fire students
- Building resilience and peer support networks
- Resources and referral pathways for those in crisis

By the end of this course, participants will be better equipped to create supportive learning environments, reduce stigma, and serve as proactive advocates for mental wellness in the EMS and fire communities. This is not just about instruction, it's about fostering a culture of care, understanding, and resilience.


WVPST Round Table/Q&A


